

Response & Recovery

- Volunteer management best practices, including Volunteer Reception Centers (VRCs) and technology for rapid mobilization.
- Case management challenges: balancing immediate relief with long-term recovery needs.
- Insurance navigation and survivor advocacy—supporting those underinsured or denied claims.
- Building stronger partnerships between VOAD/COADs and local government emergency managers.

Technology & Innovation

- Leveraging platforms for disaster response.
- Using AI, GIS, and data visualization tools for situational awareness and resource allocation.
- Cybersecurity preparedness for nonprofits and local governments during disasters

Emerging Issues

- Climate migration and its impact on housing and social services.
- Behavioral health and trauma-informed care in disaster recovery.
- Disaster legal aid and policy advocacy (e.g., FEMA reforms, insurance regulation).
